

LOCKYER VALLEY'S NATURAL RESOURCE MANAGEMENT WORKING GROUP

WORKSHOP 1

PURPOSE

The purpose of Workshop 1 held on Tuesday 25 June from 5:30pm was for each of the NRM working group members to get to know each other and agree on the principles for how we will work together to achieve our goal of creating an NRM Strategy and NRM Plan that will protect and value our natural assets in the Lockyer Valley Region.

CHECK-IN: Why does protecting and valuing the Lockyer Valley's natural assets really matter to you?

NATURAL ASSETS

We collectively agreed to use the common language of **Natural Assets** rather than "Natural Resources" or "Natural Values" because this reflects what the <u>Lockyer – Our Valley, Our Vision: Community Plan 2017-2027</u> intended. It was also agreed that "Natural Assets" has a wider scope than "Natural Resources". It is important to establish a shared language early in the process, as it not only helps the working group members communicate more effectively but it also demonstrates to the rest of the Community that we value Lockyer Valley's natural assets because assets have a value.

WORKING GROUP PRINCIPLES

We broke into groups of 4 to brainstorm what principles we felt were important to be able to effectively work together. These were stuck on the whiteboard and similar principles grouped together. Unfortunately, we ran out of time to pull them together into common statements, however the working group agreed for Renee to draft some principles and share them back to the group for comment and review.




